NOTICE IS HEREBY GIVEN that the City of Patterson Planning Commission will hold a public hearing on **Thursday, August 25, 2022, at 7:00 p.m.**, in accordance with AB 361 (Gov. Code, § 54950 et seq.), and the Federal Americans with Disabilities Act, to consider the following:

Public Hearing: Lot Line Adjustment #22-02 Buzz Oates and Rogers Road LLC, Sperry Avenue east of Rogers Road, APN's 021-085-027, 021-026-043, 021-026-017

A lot line adjustment between APNs 021-085-027, 021-026-017, and 021-026-043, east of Rogers Road and the Delta Mendota Canal, north of Sperry Avenue. The proposed adjustment would move the lot line 187 feet to the south. Currently, APN 021-085-027 (the northern parcel) totals 37.80 acres. Following the lot line adjustment, the parcel would total 44.79 acres. The southern parcel would increase from 50.1 acres to 43.15 acres. APN 021-026-017 would include a slight adjustment from a current size of 29.73 acres to 29.69 acres. The proposal is intended to better serve development of these sites.
