1. Call to Order

The regular meeting of the Patterson Economic Strategic Commission of July 19, 2018 was called to order in the City Hall, City Council Chambers, 1 Plaza, Patterson at 11:48 a.m.

3. Items from the Public

- Mr. Swift discussed reaching out to people traveling on the freeway to promote the
 museum as well as businesses in town. Putting up a sign at the stoplight right by the
 freeway to advertise businesses in town. Mr. Swift has reached out to businesses and
 organizations in town that are in favor of the sign. The sign is estimated to bring 5%
 increase in business sales. Mr. Swift would like the City to move forward with the
 project.

- City Manager Irwin discussed previous research and cost done on obtaining a sign. City Manager Irwin addressed the need to gather information as far as location, size, and if it will be rented to local businesses. - Hammon Senior Center Parking lot is underway.
- Seeking grant for Poppy Avenue water line repair.
- Update on the Self-Help Enterprises construction.
- Villages of Patterson close to starting construction.
- Annexation of property between Keystone and Walker Ranch is underway.
- Mobil/Baja Fresh has opened.
- Hampton Inn Hotel will be breaking ground on July 30, 2018.
- Burger King permit has been issued.
- Lucky's Truck Wash is in the process of obtaining a permit.
- Retail Center at Sperry and Baldwin coming soon.
- Cannabis businesses opening soon.
