"This is the time and place for the public hearing for Community Facilities District No. 2015-1 (Arambel-KND). The hearing is to inquire into the formation of the District, the formation of a Future Annexation Area and the levy of special taxes for municipal services in the District. Before I formally open the hearings, are there any property owners or registered voters in the District who wish to file written protests? If so, they must be filed with the Board Secretary now."

"The hearing is now open. We will first have presentations by staff about the District and the Future Annexation Area. After that, we will receive comments and questions and any oral protests from any interested persons. When all comments have been received the hearing will be closed."

At 8:29 p.m. Chair Molina opened the Public Hearing to public comments.

West Patterson Financing Authority Deputy Attorney White reviewed his staff report. Ken Dieker, Del Rio Advisors reviewed his staff report – power point presentation.

West Patterson Financing Authority Deputy Attorney White stated for the record that nothing discussed tonight goes toward restoration hardware.

<u>Keith Schneider, Patterson (Keystone Corp.)</u> – addressed the City Council stating he was not opposed to the formation of the CFD. Mr. Schneider reviewed his concerns with a two page power point presentation regarding; WPBP vs. Arambel BP, CFD Tax Rate Comparison 100 Acres, and Arambel Business Park, CFD Tax Rate Comparison 790 Acres.

<u>Joe Hollowell, Patterson</u> – addressed the City Council thanking Keystone Corp. for coming to Patterson. Mr. Hollowell addressed the history of Keystone Corp CFD Tax rate process. Mr. Hollowell addressed Mr. Schneider concerns.

At 9:10 p.m. there being no further public comments, Chair Molina closed the Public Hearing and stated the following:

"The hearing is closed. We may now consider and adopt "Resolution of Formation of Community Facilities District," which will establish the District and the Future Annexation Area and "Resolution Calling Special Landowner Election for Community Facilities District," which will call for the property owner vote to approve the special tax and the appropriations limit for the District."

Member Novelli moved to adopt WPFA <u>Resolution No. 2015-04</u>. The motion was seconded by Member Farinha and approved by a 3-0 roll call vote. Member Lustgarten abstained.

Member Novelli moved to adopt WPFA Resolution No. 2015-05. The motion was seconded by Member Farinha and approved by a 3-0 roll call vote. Member Lustgarten abstained.

At this time, Chair Molina stated "Will the Secretary please announce the result of the property owner vote."

At this time, West Patterson Financing Authority Secretary Vela announced the results of the property owner vote being in favor of the Ballot Measure, and completed the Canvass and Statement of Result of Election, West Patterson Financing Authority, Community Facilities District no. 2015-1 (Arambel-KDN) (attached to Resolution No. 2015-06 as Exhibit A)

At this time, Chair Molina stated "The record shows that at least 2/3rds of the property owner votes are in favor of the levy of the special taxes and the establishment of the appropriations limit. We may now proceed with the final actions for the District: (i) consideration of a "Resolution Declaring Results of Special Landowner Election and Directing Recording of Notice of Special Tax Lien," which will declare the results of the election and direct the Board Secretary to record the Notice of Special Tax Lien and (ii) introduction of an Ordinance levying the special taxes in the District. After its introduction, this Ordinance will be considered for adoption at our June 16, 2015 meeting"

Member Novelli moved to adopt WPFA <u>Resolution No. 2015-06</u>. The motion was seconded by Member Farinha and approved by a 3-0 roll call vote. Member Lustgarten abstained.
