**NOTICE IS HEREBY GIVEN** that the City of Patterson (“City”) Planning Commission will hold a Regular Meeting on **Thursday, February 23, 2023, at 7:00 p.m.**, in person AND via video conferencing and Zoom teleconference, to consider the following:

**Public Hearing:**      **Lot Line Adjustment #22-03, Eagle Valley Investments, S. 1<sup>st</sup> Street between Las Palmas Avenue and E Street, APN #'s 131-003-018, 131-003-019, 131-003-020, 131-003-025**

A lot line adjustment proposal to reconfigure four existing lots, APN 131-003-020 (a 0.48 acre lot), APN 131-003-025 (0.93 acres), APN 131-003-019 (0.62 acres), and APN 131-003-018 (1.21 acres), located south of Las Palmas Avenue, between South First Street and the railroad. After the lot line adjustment, four lots of 0.68, 0.73, 1.52, and 0.31 acres would be established. New lots would correspond to existing fire walls, where required and would meet minimum development standards outlined for areas zoned as Heavy Industrial. The proposed changes are proposed to accommodate future projects.
