

## Subbasin Announcements

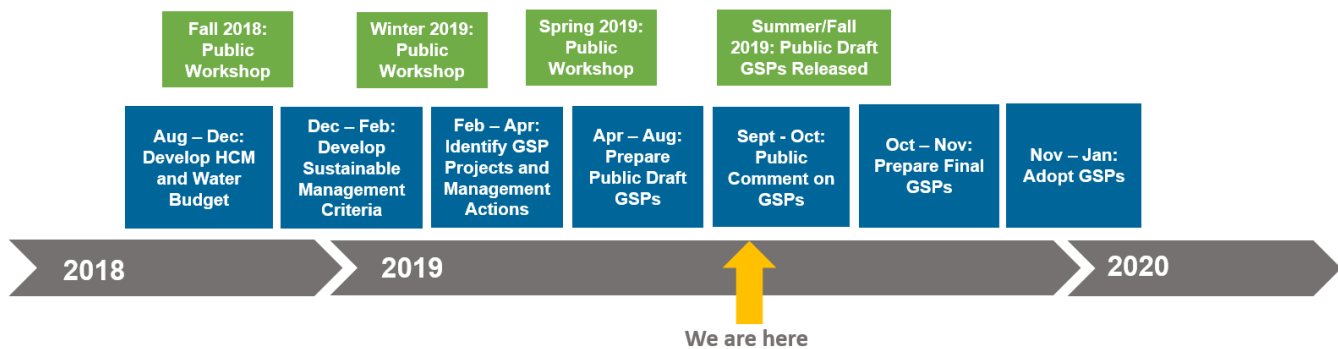
The Groundwater Sustainability Plan (GSP) Groups within the Delta-Mendota Subbasin are in the final stages of preparing their draft GSPs. Some GSP groups have released their draft GSP for public review, and have initiated the public notice of adoption period prior to final approval and adoption of their GSP. All six GSP groups are on track to adopt and submit their GSPs by the January 31, 2020 deadline for the Subbasin.

In mid-August, the Coordination Committee approved the Common Chapter and eight Technical Memoranda, which will accompany the individual GSPs and Coordination Agreement for the Subbasin. These sections provide an overview of the shared approaches and data used within the six GSPs.

The Delta-Mendota Subbasin is continuing to establish and pursue opportunities to discuss its GSPs with neighboring subbasins. Recent meetings were held with representatives from Chowchilla Subbasin, Madera Subbasin, and the McMullin Area GSA within the Kings Subbasin. As more draft GSPs are released, the Delta-Mendota Subbasin aims to continue to coordinate with neighboring subbasins to review the objectives set forth in their GSPs and to discuss overall approaches for implementation.

At this time, representatives from each GSP group are determining the process for developing the first Annual Reports for Subbasin, which will be completed by April 1, 2020. A series of meetings was held throughout August and the beginning of September to further refine the GSP groups' data management system in preparation for Annual Report development.
